Octal D-Type Latch with 3-State Output

The TC74VHC573 is an advanced high speed CMOS OCTAL LATCH with 3-STATE OUTPUT fabricated with silicon gate $\rm C^2MOS$ technology.

It achieves the high speed operation similar to equivalent Bipolar Schottky TTL while maintaining the CMOS low power dissipation.


This 8-bit D-type latch is controlled by a latch enable input (LE) and an output enable input (\overline{OE}).

When the $\overline{\rm OE}$ input is high, the eight outputs are in a high impedance state

An input protection circuit ensures that 0 to 5.5 V can be applied to the input pins without regard to the supply voltage. This device can be used to interface 5 V to 3 V systems and two supply systems such as battery back up. This circuit prevents device destruction due to mismatched supply and input voltages.

- High speed: tpd = 4.5 ns (typ.) at VCC = 5 V
- Low power dissipation: ICC = 4 μA (max) at Ta = 25°C
- High noise immunity: VNIH = VNIL = 28% VCC (min)
- Power down protection is provided on all inputs.
- Balanced propagation delays: t_{pLH} ≃ t_{pHL}
- Wide operating voltage range: VCC (opr) = 2 to 5.5 V
- Low noise: VOLP = 1.0 V (max)
- Pin and function compatible with 74ALS573






Start of commercial production 1991-11






Input Equivalent Circuit

SOP20-P-300-1.27A Unit: mm


