### 1. General description

The 74LVC2GU04-Q100 provides two unbuffered inverters. Each inverter is a single stage with unbuffered output.

The inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of this device in a mixed 3.3 V and 5 V environment.

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.













Fig. 8. Typical forward transconductance as a function of supply voltage



 $g_{fs} = \overline{\Delta V_I}$   $f_i = 1 \text{ kHz.}$  $V_O$  is constant.


Test set-up for measuring forward transconductance






Fig. 12. Package outline SOT363 (SC-88)




Fig. 13. Package outline SOT457 (TSOP6)




Fig. 14. Package outline SOT886 (XSON6)
