

The MAX3221 consists of one line driver, one line receiver, and a dual charge-pump circuit with ± 15 -kV ESD protection pin to pin (serial-port connection pins, including GND). The device meets the requirements of TIA/EIA-232-F and provides the electrical interface between an asynchronous communication controller and the serial-port connector. The charge pump and four small external capacitors allow operation from a single 3-V to 5.5-V supply. Flexible control options for power management are available when the serial port is inactive. The auto-powerdown feature functions when FORCEON is low and $\overline{FORCEOFF}$ is high. During this mode of operation, if the device does not sense a valid RS-232 signal on the receiver input, the driver output is disabled. If $\overline{FORCEOFF}$ is set low and enable (\overline{EN}) is high, both the driver and receiver are shut off, and the supply current is reduced to 1 μ A. 






Figure 1. Driver Slew Rate

Figure 2. Driver Pulse Skew










Figure 4. Receiver Enable and Disable Times



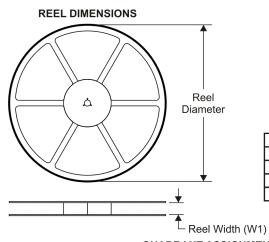
