### 1. General description

The 74CBTLV1G125 provides a single high-speed line switch. The switch is disabled when the output enable  $(\overline{OE})$  input is high.

To ensure the high-impedance OFF-state during power-up or power-down, tie  $\overline{OE}$  to the V<sub>CC</sub> through a pull-up resistor. The current-sinking capability of the driver determines the minimum value of the resistor.

Schmitt trigger action at control input makes the circuit tolerant to slower input rise and fall times across the entire  $V_{CC}$  range from 2.3 V to 3.6 V.

This device is fully specified for partial power-down applications using  $I_{OFF}$ . The  $I_{OFF}$  circuitry disables the output, preventing the damaging backflow current through the device when it is powered down.





Fig 14. Test circuit for measuring the frequency response when channel is in ON-state




Fig 16. Package outline SOT753




Fig 17. Package outline SOT886 (XSON6)





Fig 18. Package outline SOT891 (XSON6)


